society think about not only psychosis but also the other kinds of distress that are sometimes called mental illness. This report was written by a working party mainly comprised of clinical psychologists drawn from the NHS and universities, and brought together by their professional body, the British Psychological Society Division of Clinical Psychology. This report draws on and updates an earlier one, *Recent Advances in Understanding Mental Illness and Psychotic Experiences*, which was published in 2000 and was widely read and cited.
