Title III of the ADA requires that places of public accommodation (e.g., hotels, resorts, swim clubs, and sites of events open to the public) remove physical barriers in existing pools to the extent that it is readily achievable to do so (i.e., easily accomplishable and able to be carried out without much difficulty or expense).

Check local ordinances and codes for safety requirements. Use non-slip materials on the pool deck, diving board and ladders. The steps of the pool ladder should be at least three inches wide, and the ladder should have handrails on both sides small enough for a

child to grasp. There should be a ladder at both ends of the pool.

Portable pool lifts have wheels and allow movements to different areas of your pool or spa, and allow them to be stowed away when not in use. They usually function with weights and brakes and are generally battery-operated. Portable pool lifts are not permitted under the ADA. Removable pool lifts are a hybrid between portable and permanent. Ensuring staff, patrons, and swimmers stay at least 6 feet apart from those they don't live with, both in and out of the water, by providing: Physical cues or guides, such as lane lines in the water or chairs and tables on the deck. ADA Swimming Pool Accessibility - S.R.Smith

Single person pool lifts must be capable of supporting a minimum weight of 300 pounds (136 kg) and sustaining a static load of at least one and a half times the rated load. Pool lifts should be provided that meet the needs of the population they serve. Providing a pool lift with a weight capacity greater than 300 pounds (136 kg) may be advisable.

Swimming Pool Guidelines The swimming pool guidelines that are now part of the ADA law are virtually the same for both title II and title III facilities. They stipulate that any pool with under 300 linear feet of pool wall must provide one means of access, and that means must be either a pool lift or a sloped entry.

Are You Aware of ADA Requirements? Pool walls can be a barrier for those with disabilities. While pool walls cannot be removed, pool lifts and entrances can be installed to allow for equal access. The ADA's Title III instructs facilities to install these accommodations, unless doing so would involve too much difficulty or expense. Portable lifts purchased before March 15, 2012 are acceptable; however, any lifts purchased after that date must be fixed.

2010 ADA Standards for Accessible Design 1009 Swimming Pools, Wading Pools, and Spas 1009.1 General. Where provided, pool lifts, sloped entries, transfer walls, transfer systems, and pool stairs shall comply with 1009.

ADA Standards for Swimming Pools – Swim Club Insurance Program

The ADA requires businesses to make existing pools accessible only when it is "readily achievable" to do so. Readily achievable means that providing access is easily accomplishable without much difficulty or expense. The 2010 Standards provide the benchmark, or goal, for accessibility in existing pools.

ADA Pool Requirements 2019 - Texas Hotel & Lodging Association

As part of the legislation passed by the ADA, over 100,000 commercial swimming pools will be required to become accessible to people with disabilities by March 15, 2012.

Generally, this legislation will only

affect state and local government-owned facilities, parks and recreation departments, state-run schools and universities, as well as hotels, health clubs, private schools and community centers.
