The most common swimming pool ADA compliance issues include non-functioning pool lifts and training of hotel staff. The law requires that pool lifts be available for use during the pool's operational

hours. Most pool lifts become disabled because the batteries have not been charged, or have been misplaced by hotel staff.

Always put a slide in a deep area of the pool-- never in shallow water. There should be a fence at least four feet high around all sides of the pool with a locked gate to keep children out when there is no supervision and the fence should be constructed so it is difficult to climb. Lawn furniture, trees, and shrubs should not be close enough to provide an easy boost over the fence.

Swimming pools with less than 300 linear feet of pool wall must provide at least

one accessible means of entry. Means must be pool lift or sloped entry.

ADA Accessible Pools Means of Entry and Exit

Access requirements differ depending on the size of the swimming pool. For large pools with over 300 linear feet of pool wall, two means of access are required. One of these **MUST** be a primary access. For smaller pools with under 300 linear feet of pool wall, at least one means of access must be provided, and it **MUST** be primary.

Accessible Means of Entry to Pools. Section 242 of the 2010 Standards requires at least two accessible

means of entry for larger pools (300 or more linear feet) and at least one accessible entry for smaller pools.

The swimming pool, wading pool, and spa guidelines that are part of the ADA law are virtually the same for both Public Entities (Title II) and Public Accommodations (Title III) facilities. These guidelines stipulate that any swimming pool with under 300 linear feet of pool wall must provide one means of access, and that means must be either a pool lift or a sloped entry.

The ADA Accessibility Guidelines (ADAAG) is the standard applied to buildings and facilities. Recreational facilities, including swimming pools, wading pools, and spas, are among the facilities required to comply with the ADA.

Final Pool Rules - ADA

On the other hand, if a swimming pool/club located in a residential community is made available to the public for rental or use, it is covered under Title III of the

ADA. If a community pool is owned or operated by a state or local government entity, it is covered by Title II of the ADA, which requires "program accessibility."

ADA guidelines provide the specification of certain accessible elements in the design of new and renovated facilities to ensure that individuals with disabilities are generally able to access swimming pools and spas and use a variety of features of the facility.

Title III of the ADA requires that places of public accommodation (e.g., hotels, resorts, swim clubs, and sites of

events open to the public) remove physical barriers in existing pools to the extent that it is readily achievable to do so (i.e., easily accomplishable and able to be carried out without much difficulty or expense).

The final guidelines require that pools with 300 linear feet or more of pool wall provide at least two accessible means of entry into the water.⁸⁰ The primary means of entry must be a pool lift or sloped entry.
