Central to all is the fundamental question: to what extent is the human language faculty an optimal solution to minimal design specifications. Taken as a whole, the volume outlines the main features of Minimalism, its historical and conceptual sources, and provides an illustration of minimalist theorizing by looking at several properties of the syntactic component of grammar. Some contributions concentrate on what kind of computational tools are made available in a minimalist syntactic component, and how the computational system interacts with external and interface domains of the mind/brain. Other contributions specifically focus on direct empirical gains that emerge from adopting minimalist guidelines.

Parameters and Functional Heads : Essays in Comparative Syntax The Final-Over-Final Condition A Syntactic Universal

This book presents evidence for a universal word order constraint, the Final-over-Final Condition (FOFC), and discusses the theoretical implications of this phenomenon. FOFC is a syntactic condition that disallows structures where a head-initial phrase is contained in a head-final phrase in the same extended projection/domain. The authors argue that FOFC is a linguistic universal, not just a strong tendency, and not a constraint on processing. They discuss the effects of the universal in various domains, including the noun phrase, the adjective phrase, the verb phrase, and the clause. The book draws on data from a wide range of languages, including Hindi, Turkish, Basque, Finnish, Afrikaans, German, Hungarian, French, English, Italian, Romanian, Arabic, Hebrew, Mandarin, Pontic Greek, Bagirmi, Dholuo, and Thai. FOFC, the authors argue, is important because it is the only known example of a word order asymmetry pertaining to the order of heads. As such, it has significant repercussions for theories connecting the narrow syntax to linear order.
