### AMA Format Style Guide to Help College and University Students

Indents: Half-inch indents are standard (use the “tab” button) for new paragraphs. Page Numbers: Place page numbers in the top right-hand corner throughout (starting with the title page) Page Headers: Put the title of your document in the top left-hand corner of the page.

Personal communications should not be assigned a superscript number and should not be included in the list of references at the end of your paper. Listed below are two examples of in-text citations using the AMA format citation style: Example: 1. Indirect quotation (citation after a comma, period): The smoking is believed to deteriorate the breathing functions ?.

Tips: References List 3.2 Cited works are numbered in order of initial appearance in the text, and appear in the Reference List in numerical order. Use arabic superscript numerals outside periods and commas, and inside colons and semicolons.; Authors' names are inverted, and use only initials for first and middle names.
