An eviction is when a landlord forces a tenant to move out. To evict a tenant in Florida, a landlord must follow the procedure governed by Chapter 83 of the Florida Statutes. Failure to follow the proper procedure could lead to an eviction suit being dismissed, or result in the tenant being awarded fees and costs or even damages.

1. File a completed Tenant's Affidavit/Answer in Opposition to Summary Eviction. Answer to Civil Summons & Complaint in Florida
FORM 5A COMPLAINT FOR LANDLORD TO EVICT TENANTS FOR FAILURE TO PAY RENT AND TO RECOVER PAST DUE RENT INSTRUCTIONS Form 5 should be used if only eviction of the Tenant is sought.

Form 5A should be used to evict the Tenant and recover damages (past due rent).

Answering a Civil Complaint & Summons You must file an answer within the specified time frame, usually 20 days, or you will lose your right to defend yourself and participate in the court proceedings. Except for a summons for eviction, you have twenty (20) days to file an Answer to Civil Summons in Florida. When Is the Last Day to File My Answer? If the tenant chooses to fight the eviction and does not move out within the specified time period, then the landlord will typically file a complaint at the courthouse in the county where the rental property is located. The court will then set a hearing date for both the landlord and the tenant to attend (see Fla. Stat. Ann. § 83.59(2)). Once the tenant receives the landlord's complaint, the tenant will have five days to file an answer with the court.

How to Answer Your Eviction During and After COVID-19

The Answer is your opportunity to respond to the arguments in the Complaint and to explain your side of the situation. 1. Your answer must be in writing and must be filed (received) on time with the Clerk of Courts at the Courthouse of the County listed at the top of the Summons (For example, Duval County Courthouse, etc.).

These reasons are: 1. The tenant has not paid his rent on time. 2. The tenant has not complied with the requirements of the lease or has violated Florida Statutes Forms 1 and 2 contain the notices the landlord will need to send to the tenant in order to terminate the lease and evict the tenant for those two reasons.

The Summons is actually like an order from the court telling you to answer the eviction papers in 5 days. You should file your answer in the branch court where the landlord filed the eviction. You can tell the branch court by the two digit number at the end of the case number. It will say CC 05 or CC 20, etc.

If the renter leaves any personal property at the rental unit, the Florida eviction laws mandate you to notify them in writing. In Florida, the law requires that you give the tenant at least 10 days to claim the property. The 10-day period is if the notice was personally delivered to the renter.

[ANSWERING AN EVICTION COMPLAINT](#)

Responding to a summons eviction requires knowledge of the laws and process applicable to the landlord-tenant relationship in your state. Ignoring a summons eviction is never the right response because you could end up in the street. Record the date and time you received the summons eviction.

[How to Write a Legal Response to a Summons Eviction ...](#)

Your answer is due in court on the 5 th day after the eviction complaint was personally served on you or a member of your household, or posted on your door. Five days are counted just like in the Three Day Notice to Pay Rent. You don ' t count Saturdays, Sundays, and Holidays. The day you are served does not count.

After you are personally served, if you intend to oppose the eviction, you must file a written “ Answer ” to the Complaint with Superior Court within five calendar days of being served. The five days begin with the day after you receive the Complaint. This guide provides help on how to prepare and file such an Answer.
