NURSING JURISPRUDENCE EXAMINATION (NJE)

As of November 2012, DORA updated the Jurisprudence Exam. It is offered on-line only, and some of the content is new (due to changes made in Colorado law and rules). If you took the Jurisprudence Exam previous to Nov 2012 and are applying for a NEW license (not renewal of a license) then you will need to retake the Jurisprudence Exam.

Take the OT Application Jurisprudence Exam if you are:

- a new applicant, - renewing on (KBN) Jurisprudence Course time by a paper application, - provides nurses and all other stakeholders a concise explanation of the Kentucky Nursing Laws (KRS 314), Administrative Regulations (201 KAR 20) and Advisory Opinions.
