A paper is usually divided into chapters and subsections. Each chapter or section has its own heading, and these headings provide structure to a document.

Apa 6th Edition Citation

The APA style calls for three kinds of information to be included in in-text citations. The author's last name and the work's date of publication must always appear, and these items must match exactly the corresponding entry in the references list. The third kind of information, the page number, appears only in a citation to a direct quotation.

For 6 or more authors, you usually cite the first author, and then abbreviate with "et al.": Ellenbogen et al. (2013) suggests that microscopic fissures might be responsible for the damage. The damage could have been caused by microscopic fissures (Ellenbogen et al., 2013).
