Your APA format title page should include 5 elements: running head, your paper ' s title, your name, your University and author note (if required by your professor). Elements Running head: Place the running head in your page ' s header: – use label “ Running head: ” then your shortened title (IN UPPERCASE LETTERS), align left

The title page (also known as the cover page) is the

front page of your paper. It should contain the title of the paper, your name, and the institution for which you writing. These details should be aligned in the middle of the page. The running head should be in the top-left corner of the page in uppercase, prepended only on the front page with “ Running head: ” .

APA style was created by the American Psychological Association (APA). There are many different style guides (e.g., MLA, Chicago, SAA, Harvard), and each one is basically a set of rules for referencing and formatting documents.

General Format // Purdue Writing Lab

The APA manual 7th edition states that you should write your paper in an active voice and use the first person if you are discussing your research. Thus, you should say “With this investigation, I/we concluded that...” You should also use words like “suggests” or “indicates,” and be concise when writing your work.
