In general, you underline or italicize the title of an encompassing work and use quotation marks with the individual works within it. So in this case, the newspaper name would be italicized, but the articles would be in quotes.

would, however, be underlined in a works-cited list. Their titles are capitalized.

According to the Chicago Manual of Style and the Modern Language Association, titles of books (and other complete works, such as newspapers and magazines), should be italicized. So if abiding by either of those guides, you ' d italicize Stephen King ' s The Shining , just as you would Vanity Fair and The Miami Herald (and Appetite for Destruction , if your protagonist is a Guns

N ' Roses fan).

A general rule of thumb is that within the text of a paper, italicize the title of complete works but put quotation marks around titles of parts within a complete work. In MLA format, do you underline or bold the title of the ... After the year, list the title of the book in sentence case -- only capitalize the first word of the title and subtitle, if applicable, just as if you were writing a sentence. Italicize the title of the book; don't underline it or any other

part of the citation. Finally, list the location, followed by a colon, and then the publisher.
