"Texas offers the opportunity to observe lizard diversity like no other part of the country," writes Laurie J. Vitt in the foreword to *Texas Lizards*. From the moist eastern Piney Woods to the western deserts, lizards can be found in every part of Texas. The state has forty-five native and six naturalized species of lizards, almost half of the 115 species that live in the continental United States. Yet Texas lizards have not received full coverage in regional field guides, and no other guide dedicated solely to the state's lizards has ever been published. *Texas Lizards* is a complete identification guide to all fifty-one native and established exotic lizard species. It offers detailed species accounts, range maps, and excellent color photographs (including regional, gender, and age variations for many species) to aid field identification. Until now there has been no summary or overview of the wide range of work contributing to critical legal studies, the movement that has aroused such

a furor in the communities of law and political philosophy. This book outlines and evaluates the principal strands of critical legal studies, and achieves much more as well. A good deal of the writing in critical legal studies has been devoted to laying bare the contradictions in liberal thought. There have been attacks and counterattacks on the liberal position and on the more conservative law and economics position. Now Mark Kelman demonstrates that any critique of law and economics is inextricably tied to a broader critique of liberalism. There are three central contradictions in liberal thought: between a commitment to mechanically applicable rules and to standards that fluctuate with situations; between intrinsic individual values and the objective knowledge of ethical truths; and between free will and determinism. Kelman shows us the pervasiveness of these contradictions in legal doctrine; their connection to broader political theory and to visions of human nature; and, finally, the degree to which mainstream thought tends to privilege certain of these commitments over others. Irina H. Corten's *Vocabulary of Soviet Society and Culture* is an experiment in what Soviet scholars call

lingvostranovedenie—the study of a country and its culture through the peculiarities of its language. Not a conventional dictionary, Corten's lexicon is selective, offering a broad sampling of culturally significant words in the areas of politics, ideology, the economy, education, arts and letters, social problems and everyday life as well as language associated with the personalities and activities of individual Soviet leaders. The entries are listed alphabetically in English transliteration followed by the Cyrillic, although readers familiar with Russian may prefer to use the Cyrillic alphabet listing included in this volume. In each entry, the author provides a succinct but full explanation of the term and, whenever possible, cross-references to other entries, authentic examples of its use, and samples of relevant Soviet jokes. A reader may approach the lexicon either sequentially or with the aid of a subject thesaurus that divides the material into specific topics. A listing of complementary sources of reference appears in a useful bibliography. With this fascinating lexicon of "Sovietisms," Corten provides an invaluable and easily accessible medium for those general readers and scholars of the Russian language and Soviet culture

interested in understanding contemporary Soviet life. The last ten years have seen a massive growth in the number of connected wireless

devices. Billions of devices are connected and managed by wireless networks. At the same time, each device needs a high throughput to support applications such as voice, real-time video, movies, and games. Demands for wireless throughput and the number of wireless devices will always increase. In addition, there is a growing concern about energy consumption of wireless communication systems. Thus, future wireless systems have to satisfy three main requirements: i) having a high throughput; ii) simultaneously serving many users; and iii) having less energy consumption. Massive multiple-input multiple-output (MIMO) technology, where a base station (BS) equipped with very large number of antennas (collocated or distributed) serves many users in the same time-frequency resource, can meet the above requirements, and hence, it is a promising candidate technology for next generations of wireless systems. With massive antenna arrays at the BS, for most propagation environments, the channels become favorable, i.e., the channel vectors between the users and the BS are (nearly) pairwise orthogonal, and hence, linear processing is nearly optimal. A huge throughput and energy efficiency can be achieved due to the multiplexing gain and the array gain. In particular, with a simple power control scheme, Massive MIMO can offer uniformly good service for all users. In this dissertation, we focus on the performance of Massive MIMO. The dissertation consists of two main parts: fundamentals and system designs of Massive MIMO. In the first part, we focus on fundamental limits of the system performance under practical constraints such as low complexity processing, limited length of each coherence interval, intercell interference, and finite-dimensional channels. We first study the potential for power savings of the Massive MIMO uplink with maximum-ratio combining (MRC), zero-forcing, and minimum mean-square error receivers, under perfect and imperfect channels. The energy and spectral efficiency tradeoff is investigated. Secondly, we consider a physical channel model where the angular domain is divided into a finite number of distinct directions. A lower bound on the capacity is derived, and the effect of pilot contamination in this finite-dimensional channel model is analyzed. Finally, some aspects of favorable propagation in Massive MIMO under Rayleigh fading and line-of-sight (LoS) channels are investigated. We show that both Rayleigh fading and LoS

environments offer favorable propagation.

In the second part, based on the fundamental analysis in the first part, we propose some system designs for Massive MIMO. The acquisition of channel state information (CSI) is very important in Massive MIMO. Typically, the channels are estimated at the BS through uplink training. Owing to the limited length of the coherence interval, the system performance is limited by pilot contamination. To reduce the pilot contamination effect, we propose an eigenvalue-decomposition-based scheme to estimate the channel directly from the received data. The proposed scheme results in better performance compared with the conventional training schemes due to the reduced pilot contamination. Another important issue of CSI acquisition in Massive MIMO is how to acquire CSI at the users. To address this issue, we propose two channel estimation schemes at the users: i) a downlink "beamforming training" scheme, and ii) a method for blind estimation of the effective downlink channel gains. In both schemes, the channel estimation overhead is independent of the number of BS antennas. We also derive the optimal pilot and data powers as well as the training duration allocation to maximize the sum spectral efficiency of the Massive MIMO uplink with MRC receivers, for a given total energy budget spent in a coherence interval. Finally, applications of Massive MIMO in relay channels are proposed and analyzed. Specifically, we consider multipair relaying systems where many sources simultaneously communicate with many destinations in the same time-frequency resource with the help of a massive MIMO relay. A massive MIMO relay is equipped with many collocated or distributed antennas. We consider different duplexing modes (full-duplex and half-duplex) and different relaying protocols (amplify-and-forward, decode-and-forward, two-way relaying, and one-way relaying) at the relay. The potential benefits of massive MIMO technology in these relaying systems are explored in terms of spectral efficiency and power efficiency.

During the Civil War, neither the Union nor the Confederate army could have operated without effective transportation systems. Moving men, supplies, and

equipment required coordination on a massive scale, and Earl J. Hess ' s Civil War Logistics offers the first comprehensive analysis of this vital process. Utilizing an enormous array of reports, dispatches, and personal accounts by quartermasters involved in transporting war materials, Hess reveals how each conveyance system operated as well as the degree to which both armies accomplished their logistical goals. In a society just realizing the benefits of modern travel technology, both sides of the conflict faced challenges in maintaining national and regional lines of transportation. Union and Confederate quartermasters used riverboats, steamers, coastal shipping, railroads, wagon trains, pack trains, cattle herds, and their soldiers in the long and complicated chain that supported the military operations of their forces. Soldiers in blue and gray alike tried to destroy the transportation facilities of their enemy, firing on river boats and dismantling rails to disrupt opposing supply lines while defending their own means of transport. According to Hess, Union logistical efforts proved far more successful than Confederate attempts to move and supply its fighting forces, due mainly to the North ' s superior administrative management and willingness to seize transportation resources when needed. As the war went on, the Union ' s protean system grew in complexity, size, and efficiency, while that of the Confederates steadily declined in size and effectiveness until it hardly met the needs of its army. Indeed, Hess concludes that in its use of all types of military transportation, the Federal government far surpassed its opponent and thus laid the foundation for Union victory in the Civil War.

With its deeply informed guidance with respect to the methods of regulation in a domain that is heavily influenced by technological developments, this book will be welcomed by policymakers, legislators, academics, judges and practitioners working in the area of copyright law as applied to the Internet. The detailed attention to the extent to which an intermediary can be held liable for copyright infringements in both the EU and the US will prove highly beneficial for in-house counsellors and advisors working for rights holder organizations and intermediary service providers.
