The Board of Directors has to approve such purchase in accordance with the monetary limit approved by the shareholders of the company in their general meeting for that particular director or managerial personnel.

### Format of Board Resolution for Authorisation to Sign Agreement

The word “board” has no special meaning in law. When we refer to a board meeting we mean simply a meeting of the directors. A directors' resolution may require either a simple majority of votes or approval by all of the directors, depending on what is laid down in the articles. A simple majority is most common.

### CORPORATE BOARD RESOLUTION- (SAMPLE)

Decisions can be taken by directors either in a directors' meeting or by written resolution. If they take a decision in a directors' meeting, this is known as a 'board resolution'. If they take a decision by written resolution, this is sometimes called a 'directors' written resolution', although in practice this is often also referred to as a board resolution.
