To borrow, as a cosigner or otherwise, from time to time from Lender, on such terms as may be agreed upon between the Entity and Lender, such sum or sums of money as in his or her judgment should be borrowed, without limitation.

Resolution And Authority To Incur Indebtedness, Borrow ...  
Once the borrowing resolution has passed, the document goes to the bank providing the loan. The company should also keep a copy of the document internally. Generally, when a corporation or LLC needs to pass a resolution, the best option is using a template, which should be easy to fill out. If your company undergoes any major changes, and you have already filed a

banking resolution with a bank, you should alert the bank about these changes.
