What Is on the Bar Exam. Most states have a two-day bar examination. Day One is the Multistate Bar Examination (MBE), a standardized 200-item test that covers six areas (Evidence, Contracts, Constitutional Law, Criminal Law, Real Property, and Torts). Day Two is usually an essay exam with state-specific (produced by local authorities) essays.
