Part 1 (chapters 1 to 8) covers the fundamentals of GIS including coordinate systems, data models, data input, data management, and data display. Part 2 (chapters 9 to 12) includes data exploration, analysis using vector and raster data, and terrain analysis. Part 3 (chapters 13 to 16) covers spatial interpolation, GIS modeling, regions, and network and dynamic segmentation.
