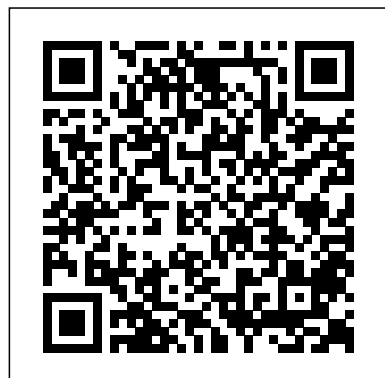

Effective April 1, 2003, revised Chapter 13 Plan and Motions (Formally Local Form 8) must be used when filing a Chapter 13 plan. Motions to Avoid Liens under 11 U.S.C. 522 (f) and Motions to Avoid Liens and Reclassify Claims in whole or in part must be so noted in Article 6 of Chapter 13 Plan and Motions and do not require separate documentation in accordance with motion practice.
