With his new ship, McCrea transported Roosevelt and the joint chiefs of staff across the Atlantic for the Tehran Conference and fought with the Fast Carrier Task Force in the Pacific. Captain McCrea's War ends in April 1945, when McCrea was summoned back to Washington after President Roosevelt's death.
