Is rapid world population growth actually coming to an end? As population growth and its consequences have become front-page issues, projections of slowing growth from such institutions as the United Nations and the World Bank have been called into question. *Beyond Six Billion* asks what such projections really say, why they say it, whether they can be trusted, and whether they can be improved.
