Subsection A of the Section 12 provides that for purposes of the disposal of an application under subsection (2), the court may, in the interest of expeditious disposal, apply such fair procedure as the circumstances of the case warrant, and shall, unless, for reasons to be recorded it directs otherwise, order any fact to be proved or disproved by affidavit.'
