lynching, and an execution. The symbolism of the title is strongly associated with the alleged African-American rape because as it would be a sin to kill a mockingbird, which does not do anything else except make music for us to enjoy, in the same manner, it would be a sin to kill Tom, who does not do anything wrong except try to help a white woman. Beyond the shadow of a doubt *To Kill a Mockingbird* is a much more complex novel and could be examined from a multitude

of perspectives on the grounds that the novel encompasses a great variety of themes and motifs. For instance, the novel could be analyzed from a feminist point of view, given that the women in *To Kill a Mockingbird* were not allowed to express their own opinions and were expected to behave accordingly to the rules of southern society. The purpose of this paper, entitled *Racial Inequality in Harper Lee's To Kill a Mockingbird*, is to examine the means
