Benevolence Policy . POLICY STATEMENT . The purpose of this policy is to set forth the conditions for which ABC Church (Church) may authorize and disburse funds that are classified as benevolence. Benevolence disbursements will only be approved to provide for the basic necessities of life to needy persons.
