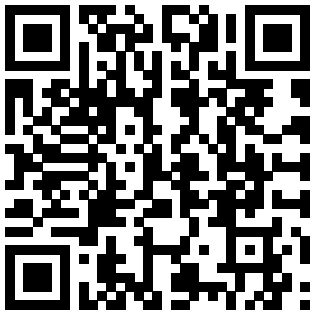

Circular Resolution under Companies Act, 2013 Section 289 of the Companies Act, 1956 relating Section 175 of the Companies Act, 2013 states about the passing of resolution by circulation. The relating provisions are as below:

A circular resolution is a documented resolution which is signed by a company ' s directors, with wording to signify they are in favour of the resolution. Typically, companies which have a constitution will have a rule enabling them to use a circular resolution as a substitute for a resolution passed at a convened director ' s meeting.

CORPORATIONS ACT 2001 - SECT 249A

Circulating resolutions of proprietary companies with more than 1 member (1) This section applies to resolutions of the members of proprietary companies that this Act or, if a company has a constitution, the company's constitution requires or permits to be passed at a general meeting. It does not apply to a resolution under section 329 to remove an auditor.

Section 175 of Companies Act, 2013 and Rule 5 of Companies (Meeting of Board and its Powers) Rules, 2014 provides for passing of Resolution by Circulation. In case of urgency, it may not be possible to wait for the approval or implementation of an item or proposal till the next meeting of Board or its Committee.
