Corporations need bank accounts to create a separate holding place for money associated with their business, and banks must know who represents the corporation as they do business together.

These resolutions are passed by the board, officially recorded by a corporate secretary and filed among a company ' s official records. The corporate resolution for signing authority is a specific corporate resolution that authorizes specific corporate officers with the legal standing to sign contracts on behalf of the corporation.

A board resolution (bank employees will often call it " BR ") is a resolution passed in a Board Meeting authorizing certain persons in a company to open and operate the bank account of a Company (Private Limited or Public Limited) or Limited Liability Partnership (LLP). A company is considered a separate legal entity (consider it as another person), the board resolution is required for opening a bank account in addition to other documents.
