Code of Professional Conduct, Coverage, says that no CPA practicing public accounting may avoid operating under a code of ethics. The CPA may not join the AI CPA or his or her state CPA society and therefore would not be subject to their codes of ethics. The CPA, however, cannot avoid being subject to his or her state board of accountancy's code of ethics
