person is unable to
cater to his
nourishment, shelter or
self protection without
supervision or
assistance of another
person.

professional the standard
for a 72-hour hold and
the answer is

And relying on this standard can and does lead to civil rights violations of individual with mental health diagnoses.

(f) " Person with mental illness " means a person who, because of a mental disorder, is one or more of the following: (A)

Dangerous to self or others. (B) Unable to provide for basic personal needs that are necessary to avoid serious physical harm in the near future, and is not receiving such care as is necessary to avoid such

harm.

The broad terms of inpatient involuntary commitment is that the

person is deemed to be a "danger to himself, a danger to others, or is incapable of taking care of his needs." If a person meets any of these criteria, he or she can be detained in a psychiatric hospital or mental health unit for observation and examination.
