Applying for disability online

If you wish to apply for your disability online, you can file for Social Security Disability or SSI. The online disability application process requires that a claims representative contact you to complete an SSI disability application if you wish to file. In other words, an SSI claim is not considered to be officially taken without the prospective claimant being contacted; whereas an SSD application can be initiated online by the claimant entirely on their own.
