CERTIFICATION OF MEDICAL RECORDS AFFIDAVIT

Confidential Records Destruction Confidential records to be destroyed must be shredded. The destruction of record copies of state records must be documented on the Destruction/Disposition of Records Form and with the signature of the program administrator or records coordinator.

Records scheduled for destruction/disposal should be secured against unauthorized or inappropriate access until the destruction/disposal of PHI is complete. The business associate agreement must provide that, upon termination of the contract, the business associate will return or destroy/dispose of all patient health information.

Medical Records Retention: The agency must have policies in place regarding the retention and destruction of medical records. For advice on record destruction, agencies are to contact agency legal counsel, or in the case of public entities, the Illinois Secretary of State's Illinois State Archives.

of a Certificate of Destruction form prior to destruction does not constitute destruction, but it may raise questions about the trustworthiness and reliability of the entire records retention program.
