Using the palmar surface of your fingers, palpate for the uterine fundus while gently pushing the cervix anteriorly with the pelvic hand. Palpate adnexa via bimanual exam. Gently slide the vaginal fingers into the lateral vaginal fornix while pushing inferiorly with the abdominal hand.

Pelvic Exam. Indications: The pelvic exam is typically done in a number of settings: As part of cervical cancer screening, which involves a PAP smear. For an average risk woman, this is offered starting at age 21, and is repeated every 3 years if the findings are normal.

evaluation of the soft tissue (skin) around the anus and well as palpation of the anal canal and testing of a stool sample for occult (hidden) blood. The skin is without erythema or induration. Sphincter tone normal. There are no masses palpated on digital exam.
