Adjustment of Status | USCIS

If you properly file Form I-485, Application to Register Permanent Residence or Adjust Status, USCIS will initially respond by mailing you a receipt notice that confirms receipt of your application. Formally known as Form I-797C, Notice of Action (see example below), the receipt notice typically arrives 2 to 3 weeks after filing.

If you need to leave the United States temporarily while your Form I-485 is pending, please see the instructions for Form I-131, Application for Travel Document, for more information. Generally, if you have a pending Form I-485 and you leave the United States without an advance parole document, you will have abandoned your application.

Form I-485 is the primary application form used by would-be immigrants who are: eligible to apply for a U.S. green card (lawful permanent residence), and also eligible to do so while living in the U.S., without leaving for an overseas consular interview.

For applicants filing the Form I-130 concurrently with Form I-485, Application to Adjust Status, it might even be overwhelming. The documents can ' t be thrown in an envelope and sent to USCIS. The forms and supporting documents to submit with Form I-485 (Application to Adjust Status) with U.S. Citizenship and Immigration Services (USCIS) can vary significantly based on the basis of your application. Family-based application packages are different than employment-based or asylum-based applications.

When you come to your interview, you (and the family member who filed the immigrant petition for you, if applicable) must bring originals of all documentation submitted with the Form I-485 application. This includes passports, official travel documents, and Form I-94, regardless if they are expired.
