(b) Superscribe the envelope with 'APPLICATION FOR TAN - Acknowledgment Number' (e.g. 'APPLICATION TAN - 88301020000244'). (c) Your acknowledgment and demand draft, if any, should reach NSDL within 15 days from the date of online application. (d) Application will be processed only on receipt of duly signed acknowledgment and realisation of payment.

In case the applicant does not have TAN allotment letter, he can submit a printout of his TAN details using TAN search facility provided at www.incometaxindia.gov.in or www.tin-nsdl.com (w) Relevant documentary proof to support request for correction/change in TAN change request to be forwarded to NSDL along with TAN acknowledgment.

TAN or Tax Deduction Account Number - All You Want To Know

Application for change or correction in TAN data for allotted TAN: The change or correction form requires details like the 10-digit TAN, category of the deductor, name, address, nationality, PAN, and TAN(s), if allotted. It also has rows to mention the changes/correction required.

Application - How to Apply It
No documents are required to be filed with the application for allotment of TAN. However, where the application is being made online, the acknowledgment which is generated after filling up the form will be required to be forwarded to NSDL.

TAN Card Application
TAN refers to Tax Deduction Account Number which is an alphanumeric

number issued to the individuals who are required to deduct tax on payments made by them under the Income Tax Act, 1961.

Documents Required for TAN Application: If TAN application is being made online then the print of the acknowledgement received

needs to be sent to the Income Tax Department. Acknowledgement of TAN is received as soon as form 49B is submitted to the NSDL website .

Once applied generally, it takes 7-10 working days for TAN allotment by NSDL. However, receipt of a physical TAN letter may take time depending upon the processing time by the department. Once the application for TAN number is made, it is always possible to know your TAN status.

You can fill and submit the form 49 B online or send a completed Form 49 B to any TIN Facilitation Centre of NSDL. It is easy to apply electronically.

Documents to be submitted with TAN application No documents are required to be submitted along with application for allotment of TAN. However, for online application, the signed acknowledgement which is generated after filling up the form is to be forwarded to NSDL.

documents showing your

' proof of identity ' and

' proof of address ' need to be sent over post/courier to NSDL

Payment: The fee for processing TAN application is INR 62 (INR 55 application charge + 12.36% Service Tax). Form No. 49B

TAN Number can be applied for online as well as offline. A Payment of Rs. 62 is required to be made for application of TAN No. The Payment can be made by Demand Draft/Cheque/ Credit Card/Debit Card/Net Banking. For making a TAN Application online, a person shall file his application in Form No.

49B on the following website of NSDL
