In 1921, five years after the appearance of his comprehensive paper on general relativity and twelve years before he left Europe permanently to join the Institute for Advanced Study, Albert Einstein visited Princeton University, where he delivered the Stafford Little Lectures for that year. Princeton University Press made the lectures available under the title The Meaning of Relativity, the first book by Einstein to be produced by an American publisher. A revised version of the appendix "Relativistic Theory of the Non-Symmetric Field," added to the posthumous edition of 1956, was Einstein's last scientific paper.
