RM is the process of identifying, assessing, and controlling risks arising from operational factors and making decisions that balance risk cost with mission benefits. The Army uses risk management (RM) to help maintain combat power while ensuring mission accomplishment in current and future operations.

Convoy safety. USAREUR & 7TH ARMY Convoy Safety Vehicle Control Factors (4) Vehicle Speed. As the vehicle's speed increases, the centrifugal force, or sideways force increases. Faster speeds also result in decreased driver response times. Speed is the factor over which the driver can exercise the most control.

operation, including training and combat. DD Form 2977 is designed for the entire Army and the other Services.

Appendix Examples of Risk Management Application

This becomes the overall mission or task risk level. The commander decides whether the controls are sufficient to accept the level of residual risk. If the risk is too great to continue the mission or task, the commander directs development of additional controls or modifies, changes, or rejects the COA.
