Yet outbreaks of group revelry persist, as Ehrenreich shows, pointing to the 1960s rock-and-roll rebellion and the more recent "carnivalization" of sports. Watson and Rosalie Rayner is one of the most influential, infamous and iconic research articles ever published in the history of psychology. Commonly referred to as "The Case of Little Albert" this psychology classic attempted to show how fear could be induced in an infant through

classical conditioning. Originally published in 1920, *Conditioned Emotional Reactions* remains among the most frequently cited journal articles in introductory psychology courses and textbooks. technique by means of which we could remove the conditioned emotional responses was denied us." This unforeseen turn of events was something that obviously stayed with Watson, as under his guidance some three years later, Mary Cover Jones conducted a follow-up study - *A Laboratory Study of Fear: The Case of Peter* - which illustrated how fear may be removed under laboratory conditions. This additional and highly relevant article is also presented in full. The Case of Little Albert has been
