Building Regulations and Fire Safety

This title was first published in 2000: This text tackles the allied subjects of fire prevention, fire protection and fire safety management and takes account of changes to the building regulations and associated guidance in England and Wales which apply from 1 July 2000. The approach adopted is to divide the subject of fire safety into a number of discrete components,

for example: fire prevention; means of escape; emergency lighting; fire safety signs; and fire detection and alarm systems.
