Height of the Flood. Only a global flood would cover all the high mountains under the heavens by at least 15 cubits (about 25 feet or 7 meters: Genesis 7:19). Since water always seeks the lowest level, to cover just the mountains in the Middle East would result in a global flood. Duration of the Flood. From the beginning of the flood until the people and animals disembarked on dry ground was 371 days (Genesis 7:11 and 8:14).
