Substance Abuse Professionals (SAPs) are licensed or certified professionals that have knowledge not only of the diagnosis and treatment of alcohol and controlled substances related disorders, but also of DOT drug and alcohol testing and return-to-duty processes as required by §40.281. A DOT-qualified SAP initially evaluates drivers who have violated DOT drug and alcohol regulations and makes ...
