During the process, many fascinating experimental cars, such as the Mustang I two-seater, Mustang II prototype, Mustang Allegro, and Shorty, were built. But eventually the Mustang, based on the existing Ford Falcon, received the nod for final production. In a gala event, it was unveiled at the 1964 World's Fair in New York. After the initial success, Ford designers and Gale Halderman designed and developed the first fastback Mustangs to compliment the coupes. They poorly protect occupants and inflict horrific damage in crashes, they guzzle gasoline, and they are hard to control.
