Topology is the mathematical study of the most basic geometrical structure of a space. Mathematical physics uses topological spaces as the formal means for describing physical space and time. Applications of the theory to discrete spaces (where the standard theory of open sets gets little purchase) are particularly noted. The mathematics is developed up through homotopy theory and compactness, along with ways to represent both affine (straight line) and metrical structure.
