Kenneth Strickfaden, innovative genius of illusionary special effects from silent films to the age of television, set the standard for Hollywood ' s mad scientists. Strickfaden created the science fiction apparatus in more than 100 motion picture films and

television programs, from 1931 ' s Frankenstein to the Wizard of Oz and The Mask of Fu Manchu to television ' s The Munsters. The skilled technician, known around Hollywood ' s back lots as " Mr. Electric, " once doubled for Boris Karloff in a dangerous scene and was nearly electrocuted. From his birth in 1896 to his death in 1984, Strickfaden ' s life was filled with adventure. He spent his early years working the amusement parks on both coasts, served overseas as a Marine during World War I, took a 1919 cross-country trip in a dilapidated Model T, and favored risky pursuits like automobile and speedboat racing. He worked as an aeronautical mechanic, constructing airplanes for an historic around-the-world flight. A science

teacher at heart, he gave 1,500 traveling science demonstration lectures across the U.S. and Canada. Besides covering Strickfaden's entire personal and professional life, this book discusses how later films show his influence. It reveals the fate of his collection of equipment, and is richly illustrated with numerous rare and previously unpublished photographs.

Appendices provide a selection of notes, doodles, and scribbles from Strickfaden's notebooks, informal sketches, correspondence, documents, a chronology of his film and television contributions, a bibliography, a film index, and a complete subject index.

Characterization of nineteenth-

century literary Gothic is usually confined to affective response. This project argues that literary Gothic works constitute an intellectual, empirical endeavor. Because authors of literary Gothic intentionally left voids in their narratives, they invited their readers to participate in making narrative through speculation and conjecture about missing information. The practice of Gothic reading makes the reader an active partaker in filling those voids with rational conclusions. Reading is not just textual encounter. Rather, it incorporates making meaning of one's surroundings. In their experiences, literary works' characters "read" their environments: people, objects,

events, etc. Chapter 1 characterizes Gothic reading as the employment of logical processes; Northanger Abbey's Catherine Morland uses induction, deduction and syllogism to make sense of--read--her world. In Chapter 2, Frankenstein presents reading as audience engagement between characters as they tell their stories. Shelley uses sympathy as a social-bonding device in which characters read other characters through listening. Chapter 3 examines Jane Eyre through the motif of the legend of Bluebeard's House. The house serves as a narrative that Bluebeard's Wife must read and decode for its danger. With her keys, she can unlock the spaces of that narrative. Standing in for the reader, Jane attempts to unlock Thornfield's narrative through investigation. Both Jane and the reader use "keys" of unexplainable things to unlock the secrets within the narrative; the Gothic author endows the reader with keys of mysterious objects, people, and events. Reading continually opens up answers. In the final chapter, this project argues for Gothic as detective fiction. In their narrative structure and storylines, Dracula and The Strange Case of Dr. Jekyll and Mr. Hyde allow for the reader to sleuth out mysteries. Dracula's Seward and van Helsing perform detective work on Renfield and Dracula, respectively. Additionally, each man represents a

different style of reasoning, Seward algorithmic and Helsing heuristic. Meanwhile, Utterson the attorney must play detective to determine the nature of the relationship between Henry Jekyll and Edward Hyde. All three characters read their environments as part of their detection.

Frankenstein was first released in 1818 anonymously. The credit for Mary Wollstonecraft Shelley's authorship first occurred in 1823 when a French edition

was published. A year earlier, Mary's revolutionary husband, the influential poet, dramatist, novelist, and essayist Percy Bysshe Shelley, died. The same year *Frankenstein, or, The Modern Prometheus* (its full title) was first published, so was another work by Mary's husband that shares use of the word Prometheus. The drama *Prometheus Unbound* was indeed credited to Percy Shelley. The secret admission of many experts in English literature is that Mary Wollstonecraft Shelley did not write a good portion of *Frankenstein*. In *Shelley Unbound*, Oxford scholar Scott D. de Hart examines the critical information about Percy Shelley's scientific avocations, his disputes against church and state, and his connection to the illegal and infamous anti-Catholic

organization, the Illuminati.
