Drawing on a rich trove of documents, including  
correspondence not seen for 300 years, this  
study explores the emergence and growth of a  
remarkable global trade network operated by  
Armenian silk merchants from a small outpost in  
the Persian Empire. Based in New Julfa,  
Isfahan, in what is now Iran, these merchants
