completeness, and applications to algebra. This chapter also continues the foundational issues begun in the set theory chapter. Mathematics can now be viewed as formal proofs from ZFC. Also, model theory leads to models of set theory. This includes a discussion of absoluteness, and an analysis of models such as $H(\kappa)$ and $R(\kappa)$. The Recursion Theory chapter develops some basic facts about computable functions, and uses them to prove a number of results of foundational importance; in particular, Church's theorem on the undecidability of logical consequence, the incompleteness theorems of Gödel, and Tarski's theorem on the non-definability of truth.
