Massachusetts compulsory school attendance age. The law requires that children attend school or be homeschooled from the first school year in which they turn 6 by December 31 until their 16th birthday. HSLDA believes that a parent-issued diploma and transcript should be sufficient to demonstrate that a child has completed a secondary education.
