The idea of a right to privacy, which arose in reaction to the rapid rise of newspapers, instant photography and the "paparazzi" of the 19th century, has evolved into a constitutional right in much of the developed world. It is enshrined in Hong Kong through Articles 28, 29, 30 and 39 of the Basic Law.
