Though these men lived in different times and places, and came from vastly different backgrounds, many of them share similar, abnormal personality traits and, in some cases, mental disorders, including "The Dark Triad:" malignant narcissism, psychopathy and paranoid personalities. *Tyrannical Minds* reveals how recognizing these traits can provide insight into their motivations and actions, potentially allow us predict their behavior—and even how to stop them.
