Therapy minutes cannot be rounded for the purposes of documenting the . required intensity. The . patient's IRF medical record must document that the required therapy treatments began within 36 hours from midnight of the day of admission to the IRF. Therapy evaluations done in the IRF constitute initiation of the required therapy services.

INPATIENT REHABILITATION FACILITY (IRF)

Documentation must indicate that therapy treatment was individualized, or one-on-one. Group therapies should serve as an adjunct to individual therapies. If an unexpected clinical event occurred during the course of the IRF treatment and limited the patient's participation, the medical record documentation must indicate the reasons for the break.
