Fifty years ago Harry S. Truman pulled off the greatest upset in U.S. political history. It encompassed Truman's rousing "Give 'em Hell Harry" speeches and intriguing behind-the-scenes political maneuvering. It was the first election after Roosevelt's death and the last before the advent of television. It marked the new political prominence of African American voters and organized labor, as well as the South's declining influence over the Democratic Party.
