extent to which this research currently influences undergraduate instruction, and identifies the intellectual and material resources required to further develop DBER. In addition, the findings and recommendations of this report may invite, if not assist, post-secondary institutions to increase interest and research activity in DBER and improve its quality and usefulness across all natural science disciplines, as well as guide instruction and assessment across natural science courses to improve student learning.
