Once understood, one goes on to develop applications. In my plan to present an outline of biomechanics, I followed the engineering approach and used three volumes. Properties of Living Tissues, the geometrical structure and the rheological properties of various materials, tissues, and organs are presented. In the second volume, *Biodynamics: Circulation*, the physiology of blood circulation is analyzed by the engineering method.

Second, the last section of the book develops the application of biomechanics in qualitative analysis of several movements in four professional areas: physical education, coaching, strength & conditioning, and sports medicine. These guided tours of the application of biomechanics to solve human movement problems are similar to the extensive interdisciplinary qualitative analysis tutorials in Knudson & Morrison (2002).
