The implication of the EMH for investors is that, to the extent that speculative trading is costly, speculation must be a loser's game. undertake trades with long verification periods. The actions of these arbitrageurs cause liquid securities markets to be generally fairly efficient with respect to information, despite some notable anomalies.
