Atrazine is a restricted use pesticide due to ground & surface water concerns. Atrazine application rates are limited to 2.5 lbs per acre per calendar year; restricts rates to 1.5 lbs in 23 counties (7 county -wide 16 in some townships); may not be mixed, loaded, or repackaged within 50 feet of a sinkhole, well, cistern, lake, water impoundment, this includes, but is not limited to, abandoned ...

To become certified, all private applicators must pass a 50 question, closed-book certification exam over the Private Pesticide Applicator Study Guide (available from the Extension Distribution Center). If the exam is failed (<70%), it may be taken again.

However, the exam may be taken only once each day.

hours of continuing instruction approved by the Iowa Department of Agriculture and Land Stewardship (IDALS) for each of the three years certified OR completing the written exam at the end of the three years for renewal. Training year runs from April 16 through the following April 15 and are usually held November through March. For initial certification, an applicant must
